Langton Primary School Parents and Carers Code of Conduct

Introduction and Purpose: At the Langton Primary School, we are committed to working in partnership with parents and carers to provide an excellent education for all our pupils. This code of conduct outlines the expectations we have for parents and carers to ensure a positive and productive relationship that supports our school's vision and values.

Core Values and Principles: As part of the Langton community, we expect parents and carers to uphold our core values of excellence, respect, nurture, creativity, collaboration, and resilience. These values guide our actions and underpins the way we work together to support our pupils.

Expected Behaviours and Conduct: To maintain a safe, caring, and productive environment for our school community, we expect parents and carers to:

- Treat all members of the school community, including staff, pupils, and other parents, with respect and courtesy.
- Support the school's policies and procedures, including those related to behaviour, attendance, and safeguarding.
- Communicate with the school in a calm and constructive manner, avoiding the use of abusive or threatening language, either in person, on the phone, or in written communication.
- Refrain from publicly criticising or making derogatory comments about the school, its staff, or other members of the school community.
- Attend meetings and events organised by the school, where possible, to stay informed and engaged with their child's education.
- Support their child's learning by encouraging them to participate fully in school life and complete any homework or other assignments to the best of their ability.

Communication Guidelines: We encourage open and regular communication between the school and parents/carers. To ensure effective and appropriate communication, we ask that parents and carers:

- Contact the school using the correct channels, such as the school office or the appropriate member of staff, and avoid approaching staff directly during the school day.
- Respect the school's communication policies, such as response times and the use of email or other digital platforms.
- Attend scheduled parent-teacher meetings and respond promptly to any requests for information or feedback from the school.

Responsibilities of Parents and Carers: As partners in your child's education, we expect parents and carers to:

- Ensure their child attends school regularly, on time, and ready to learn.
- Inform the school of any issues or concerns that may affect their child's wellbeing or ability to learn.

- Support their child's learning at home, including by reading with them, helping with homework, and encouraging them to develop a positive attitude towards their education.

- A formal letter outlining the school's expectations and the consequences of continued non-compliance.
- Restricting the parent or carer's access to the school site or staff, if their behaviour is deemed unacceptable.
- In extreme cases, the school may consider legal action to protect its staff and pupils.
